## REGISTRATION

- ◆ Application & Testing Fee is a one-time fee, due at the time of application, non-refundable.
- ◆ Application & Testing Fee includes: processing and building the admissions file, and student testing.
- ◆ Registration Fee is an annual fee, due at the time of registration. The registration fee is non-refundable for returning students. For new students, the registration fee is refundable if the student is not accepted by Heights Christian Schools for enrollment. However, if a new student is accepted but later withdraws, the Registration Fee is non-refundable.
- ◆ Registration Fee includes: textbook usage, consumable supplies, office records, supplemental student accident insurance, SAT testing, yearbook materials, earthquake kits, and ACSI membership.
- ◆ All required documents and fees must be submitted in order to complete the enrollment process.
- ◆ Enrollment for new and returning students (who are in good standing) is on a first-come basis.
- ◆ If there is a waiting list for new students, being first on the waiting list is not a guarantee of next placement.

## TUITION AND STUDENT ACCOUNT

- ◆ Multi-child discount applies to families with two or more children enrolled FULL-TIME at any of our schools. If there is a FULL-TIME preschooler, the preschooler counts as the "first child." If there are multiple FULL-TIME preschoolers, the youngest preschooler counts as the "first child."
- ◆ No discounts other than those listed (on the reverse side) are available.
- ◆ Tuition is an annual fee based on the actual number of school days and does not include holidays or breaks. Payment options are available for your convenience.
- ◆ **All payments are due on the 1<sup>st</sup> of the month** (tuition, daycare, late pick-up fees, extracurricular activities, etc.). Accounts with any outstanding balance after the 5<sup>th</sup> of each month will be assessed a late fee of \$25.
- ◆ When making a payment, the payment will first be applied to any outstanding balance on the account, and the remainder will then be applied to the current balance.
- ◆ Accounts that are not paid in full by the end of each month may result in the student being dis-enrolled. Report cards will be held until final payments are made.
- ◆ A service charge of \$40 will be assessed for each returned payment, such as NSF check or NSF e-check. After two occurrences of returned payments, *only* cash, credit or money orders will be accepted for future payments.
- ◆ In the event of early withdrawal, tuition will be due through the last day of actual enrollment *plus* 10% of the annual tuition.
- ◆ Tardy policy is \$1 per minute per student for excessive tardies.

## TECHNOLOGY FEE

- ◆ The technology fee is an annual fee that applies to students in 3<sup>rd</sup> and 4<sup>th</sup> grade. The fee covers the device, support and infrastructure. The technology fee will be billed to the student account each year on September 1.

## DAYCARE

- ◆ The daycare fee for second and additional children enrolled in the same program is discounted. See the Tuition Agreement for rates.
- ◆ Payments for daycare are due on the 1<sup>st</sup> of the month; late fees will apply.
- ◆ A fine of \$1 per minute per student is charged for students picked up after 6:00PM.
- ◆ Emergency use of Extended Daycare is \$5 per hour (or any part thereof) per student.
- ◆ Emergency use is limited to 5 uses per year. If emergency use exceeds 5 per year, then the monthly Extended Daycare rate will be applied to your account.
- ◆ Participation in Extended Daycare is a privilege. Violation of any of the conditions of school enrollment may result in a student being refused the use of the Extended Daycare program.
- ◆ The daycare fee for second and additional children enrolled in the same program at the JH is not discounted.

## HOLIDAY DAYCARE

- ◆ Holiday Daycare is available on Martin Luther King's Birthday, Veterans' Day, Teacher In-Service days, Teacher Conference days, Easter Break, Christmas Break (except Dec. 25 through Jan. 1, typically).
- ◆ Students enrolled in **Combined** Extended Daycare will receive Holiday Daycare at no extra charge, except for Easter Break and Christmas Break, which are an additional fee.
- ◆ The campus and school office are closed on the following holidays: Presidents' Day, Good Friday, Memorial Day, Labor Day, Thanksgiving (Thursday and Friday), and Christmas break (Typically December 24 at noon through January 1). There is no Holiday Daycare available on these days.

## PAYMENTS

- ◆ Payments can be made online through ParentsWeb using credit card, debit card, or e-check.
- ◆ We accept Visa, MasterCard, and Discover.
- ◆ Payments can be made in the school office drop box using check or money order.
