The primary purpose of technology systems at Heights Christian Schools is to improve/enhance learning and teaching. The Technology Use Guidelines should be read and reviewed carefully. They are designed to help students and parents understand appropriate uses of technology at school. It is expected that students will use these technology and resources responsibly and for educational purposes that align with the mission and philosophy of the school. As such, any technology used at the school may be accessed by faculty and administrators at any time.

- Students in TK-Kindergarten will have 1:1 access to iPads in their classrooms. Students in 1st - 4th grades will have 1:1 access to Chromebooks in their classroom. Students in 5th - 8th grades will be issued a Chromebook and will transport their devices between home and school. Devices remain the property of HCS and will be collected at the end of each school year.
- In the event a replacement unit is needed due to damage caused by the student, the parent(s) will be required to purchase a replacement device through HCS. Bring Your Own Device (BOYD) is not permitted to ensure the device has the proper HCS specifications and software installed. The approximate cost for a replacement device is \$300.

PERTAINING TO STUDENTS IN 5TH - 8TH GRADES

- Devices issued to students will be inspected by HCS and in good working order: All connection ports functioning normally; the device and charger working properly, and no structural or screen damage other than normal wear and tear.
- It is the responsibility of the parent(s) to ensure students take care of the device assigned to their child; parents bear full fiscal responsibility for any repairs and/or replacement of the device if lost, stolen, or damaged in any way that renders it unusable.
- It is the student's responsibility to bring the Chromebook to school every day, fully charged and ready for use in the classroom.
- In the event that a student requires the use of a rental or loaner device, the student will be responsible for the rental/loaner device and will assume financial responsibility if it is lost or damaged while in their child's possession. Daily fees will apply for rental devices.
- Inappropriate use of technology on or off campus will be dealt with swiftly and fairly and will result in appropriate disciplinary action, up to and including, suspension or termination of enrollment. The school reserves the right to determine, in its discretion, when conduct is of such a severe nature as to warrant immediate action without warning and/or without an intermediate step short of withdrawal. All disciplinary actions, including suspension or termination of enrollment, are at the sole discretion of the HCS administration.
